### Payment processing time

All payments performed before 14:30 CET will be executed on the same day. Payments performed after 14:30 CET will be executed on the next business day. Notification about public holidays will be send to client by mail a few days before.

### Internal transfer:

Internal transfer within the same tariff client category is free of charge. If client withdraws funds to different client category account fee from table will be applied.

### Online money transfers

Money transfers are processed instantly and are ready for payment within 15 minutes.

### Outward to debit card (RUB, UAH)

Transfers credited to a VISA / Mastercard debit card are available:

- in Russian rubles for cards issued by banks of the Russian Federation  
Transaction limit - equivalent to 100,000 rubles
- in Ukrainian hryvnias for cards issued by banks of Ukraine  
Transaction limit - equivalent to 4,500 euros

#### **Outward to cash**

The total commission for a cash payment transfer is calculated at the time the transfer is executed and depends on the recipient country and the counterparty commission.  
The limit for sending a transfer equivalent to 8,000 euros.

#### **Account statement by post:**

Indicated fee is for one-month statement from one account. Tracking post number will be provided to the client.

#### **Letter of good standing**

Indicated fee is deducted for one copy of the letter. Letter of good standing will be sent by UPS and tracking number will be provided to the client.

#### **Penalty for client's significant failure to cooperate**

Applies for clients who fail to provide the full extent of information and documentation by deadline specified in the FAS Finance Company request.

#### **Monthly terminated account maintenance:**

Debited from account the first day of the month.

#### **Outward payment from terminated account**

The payment only to the customer's account by SEPA payment. The customer shall provide proof of account ownership in advance.
